### **Commitment to Privacy**

This site, [www.psmodcom.org](http://www.psmodcom.org) and all sites that we may own and operate in the future is owned by Palm Springs Modern Committee ("Site", "psmodcom.org", "we" or "our"). Psmodcom.org respects the privacy of every individual who uses the Site and we will only process and use the data obtained through the Site to provide you with information, services and other services we think may be of interest to you. Our privacy policy ("Privacy Policy") outlines the information we will collect and how we will use that information.

### **Personally Identifiable Information**

When you access and use this Site, we or our service providers may obtain data concerning that access and use. If you request information from us or register to use any limited access portions of

the Site, you will be asked to provide personally identifiable information about yourself. This data may include, but is not limited to, your first name, last name, mailing address, postal/zip code, phone numbers, country, company information and e-mail address. You may provide additional information at your discretion. We will not collect any personally identifiable information about you unless you

provide it to us voluntarily. If you opt not to provide us with personally identifiable information, no material consequences will result, although there may be functionality on the Site that may be unavailable to you.

### **Use of Personally Identifiable Information**

We may store and process your personally identifiable information in order to fulfill any requests for information that you make of us, provide you access to "members only" portions of the Site, or to better understand your needs and to learn how to improve our Site offerings. We may also use your personally identifiable information to contact you (for example, we may respond to your comments or requests for information, or advise you on your membership status). Palm Springs Modern Committee will not share personal information with third parties (other marketers), period.

### **Contributions**

You may purchase memberships, merchandise or event tickets, or make a donation, through the Site. When such transactions are made, you will be asked to submit certain information such as your name, mailing address, email address, employer, occupation, credit/debit card information, etc. We process all credit/debit card transactions via PayPal for the payment gateway services. PayPal will treat your financial information in the manner required by applicable law.

### **Contacting Us Regarding Your Personally Identifiable Information**

If you have submitted personally identifiable information through the Site and no longer wish to be contacted, please unsubscribe at [info@psmodcom.org](mailto:info@psmodcom.org). We will then use reasonable efforts to change or remove you from our contacts list, unless we are entitled or required to retain it pursuant

to other agreements or by law. We will use reasonable efforts to supply you with this information and correct any factual inaccuracies in this information. Notwithstanding the prior two sentences, if the laws in your state provide you with additional protections or requires us to comply with more stringent obligations to provide you with, remove, or correct your personally identifiable information, we will comply with those legal requirements.

### **Non-Personally Identifiable Information Collected Automatically**

In some cases, we may collect information about you that is not personally identifiable. Examples of this type of information include but are not limited to the frequency of your use of the Site or the Site's electronic correspondence to you and the route by which you choose to access the Site and your use of any available hyperlinks (e.g. using cookies and web beacons). We and our service providers, agents or advisors may process and use this data for purposes including but not limited to, planning Site development, assessing patterns of use, or to include you in e-mail or mailing lists so that we may send you information or updates and or offer you services.

### **Cookies**

"Cookies" are small text files that are either used for the duration of a session ('session cookies'), or saved on a user's hard drive in order to identify that user the next time he/she logs on to the Site ('persistent cookies'). We may use 'session cookies' to identify registered users logging in to the Site. These cookies are deleted from the server soon after the session ends and are not collected or saved. Most Web browsers automatically accept cookies, but you can usually change your browser to prevent that, although if you do disable cookies from your browser you may not be able to access certain sections of the Site.

### **Security**

We use reasonable measures to protect personal information from access by unauthorized persons. This includes, among other things, standard techniques such as firewalls, encryption, intrusion detection, and site monitoring. We also use reasonable internal controls to protect personal information from misuse by our employees. Unfortunately, no electronic data or transmission can be guaranteed to be 100% secure. As a result, while we use reasonable measures to protect personal information, we cannot ensure or warrant the security of any

information transmitted or otherwise provided to the Site or received from the Site.
